#### Climate

Mumbai enjoys a tropical climate, with its warm sunny weather playing a huge part in the regions' successful tourist industry. Thanks to its location next to the Arabian Sea, Mumbai sees warm and temperate coastal weather year-round, ideal for enjoying the beaches and seas, with little variation in temperatures. The monsoon season brings a dramatic change in conditions, however, and runs for four months of the year. An ideal time to visit, for plenty of tropical sunshine is the period between November to March, with temperatures averaging between 21-31 degree centigrade and the days filled with blue skies and plenty of sunshine.

### **Currency and Exchange Rate**

Currency can be exchanged at the airport, banks, hotels and bureau de change. Banks are open from Monday to Saturday. ATMs are available in most cities and tourist resorts. Most large hotels and shops accept traveler's cheques and major credit cards.

Central Mumbai - the geographical centre of Mumbai, up market residential area with plush restaurants, bars and eating places.

North Mumbai - the residential suburbs with predominantly high-rise residential buildings and large shopping malls. The Queen of suburbs - Bandra is the high point for eating. Almost every day there is a new eatery opening up here.
