We have partnered with Symbiont to

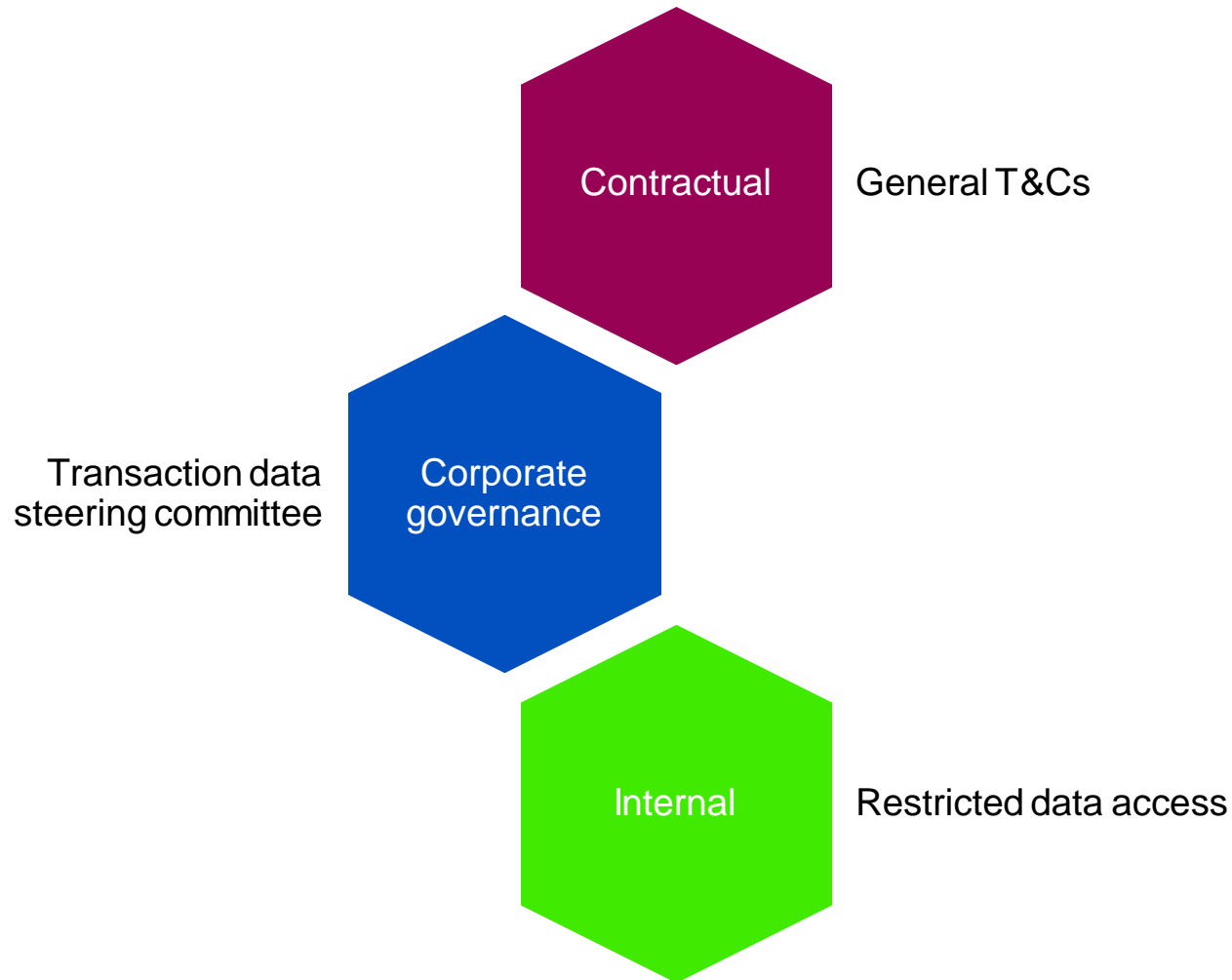
1. **Deploy a blockchain** network with multiple nodes
2. **A selective and secure CA data sharing environment** that creates a shared view of an event.
3. **Use smart contracts** to compare shared data (in SWIFT messages) among participants and flag discrepancies, contradictions or inconsistencies across custodians
4. **Test the value of a number of additional ideas** including how to use SWIFT data in a blockchain or SWIFT's AI capabilities to normalize the data



- A no touch experience for CA processing teams
- An easy and secure way to share corporate action data
- A shared source market-wide scrubbed view of events and event choices
- Automatic flagging of discrepancies / inconsistencies across custodians
- Better way to communicate questions to custodians
- Automatic comparison of custody feeds vs data vendor feeds (Bloomberg, etc.)
- Automatic reconciliation of elections, status and confirmations
- Timeline history linking preliminary, replacements, amendments and final notifications
- AI is capable of normalizing data
