Survey on Business Continuity Planning for COVID-19

- CDC disseminated COVID-19 Flash notes to ACG members specifying the "Global Best Practices" adopted by CSDs to ensure safety measures.
- A survey was circulated among the ACG member CSDs, designed to examine their scope of business continuity planning.

The COVID-19 pandemic forced a paradigm shift in the way companies conduct operations globally. As the convener of the RRM Taskforce, CDC examined how the various member depositories dealing with the crisis and keeping the critical component of the capital market operational despite the enormous challenges faced in implementing the measures.
